President-CEO / Board Chair Message

There are several reasons Vista Hill enjoyed another successful year of providing vitally needed mental/behavioral health, educational and social services to more than 25,000 individuals and families in San Diego County. Near the top of those critical factors are the various partnerships we've established over the years.

For example, we could not do our work without the help of our funding partners, such as the County of San Diego and the San Diego Regional Center. We also appreciate the supportive

foundation grants and the many donors—big and small—whose remarkable generosity allows us to greatly enhance or expand the services we provide.

There's no better illustration of how partnerships help Vista Hill than our PROMOTE! Program. This three-way partnership among Vista Hill, Escondido Union Elementary School District and the County of San Diego—Behavioral Health Services furthers the educational progress and well-being of school students

3 to 8 years of age that are at risk for developing problem behaviors and mental health conditions.

Just recently, we were able to expand this program thanks to a \$105,000 grant from the Prebys Foundation. Our school district partner provided a separate new grant, allowing us to expand the program from seven to 12 elementary schools in which we now serve more than 2,000 students.

Here's another great example of partnership: Rotary Club of Rancho Bernardo volunteers have a community project in which they regularly re-stock the pantry at our ParentCare East program with healthy food, household goods and emergency supplies from the San Diego Food Bank. This service is vital to our program participants and their families.

We will seek new partnerships in the coming year. We're currently working on a potential partnership with the University of California, San Francisco to help them implement California's new Children and Youth Behavioral Health Initiative, a historic investment by the state to address the factors that contribute to the mental health and well-being of our children and youth. Our role will be to provide brief child and adolescent psychiatry e-consultations to San Diego pediatricians with privately insured patients. Our successful Smart-Care Behavioral Health Consultation Services will continue offering in-depth consultation and training resources to pediatricians with their Medi-Cal patients.

We hope you enjoy our cover story on the new Chula Vista home for our Stein Education Center Adult Day Program. The purchase and renovation of the building in Chula Vista has created excitement and increased stability for 70 clients

with intellectual and developmental disabilities, while saving Vista Hill tens of thousands of dollars in rent we were previously paying.

We also offer our appreciation to Mark Chenven M.D., who served as Vista Hill's Medical Director for almost 25 years. To succeed Dr. Chenven, we welcome two outstanding child and adolescent psychiatrists—Dr. Charmi Patel Rao and Dr. Shawn Sidhu—who will serve as Co-Medical Directors (see story, page 7).

Finally, we want to express our deepest gratitude for the long and remarkable tenure of Mr. Cecil H. Steppe as a Vista Hill Board Member starting in 2000 and as Board Chairman since 2007. You'll read more about Mr. Steppe's dedicated service on page 7.

As we look forward to 2025, we know the foundation of another successful year will be—as it always has been—the work of our amazing and talented staff of professionals who deliver our myriad of services to thousands of people who benefit from their tireless dedication.

New Chula Vista Home For Stein Adult Services Enhances and Stabilizes Key Program

ne of Vista Hill's most successful and effective programs just got even better thanks to the recent opening of a new building in Chula Vista to house the Stein Education Center's Golden Family Adult Services program.

"Everyone from our clients, their families and our staff are thrilled with our new state-of-the art facility," says Senior Director Joanne Garcia.

"Having a permanent home that we actually own has increased our ability to provide additional and even more effective services to a clientele that relies so much on the lifeline we offer them."

The Adult Services program, which serves 70 South Bay residents with and intellectual

developmental disabilities, works to improve the clients' quality of life by maximizing independence and advocating for community inclusion.

The new building ends a period in which the program had to adapt to lease termination at a National City

provided at community locations or through video streaming. With Vista Hill owning the building, tens of thousands of dollars will be saved in rent in the coming years.

With the full array of services solidly in place, the program is providing clients with meaningful, creative and engaging training opportunities on-site and in community integrated

> settings; positive behavior intervention methods; pretrainvocational ing and volunteer opportunities; skill development improve language, social interaction and independence; and group activities such as exercise, art and music classes.

> "We feel the services we provide our clients are some

of the most important in the community," Garcia says. "Our clients are given the skills to create meaningful and productive lives. And their families benefit by being freed up for five hours a day so they can work or do errands."

Family Cherishes Adult Services Program For Decades of Positive Impact on Son

If you want to understand the **I**powerful impact Stein Education Center's Adult Services program has on lives, just spend a few minutes with Amparo and Nolito Laberinto.

The South Bay couple placed their son, Noel, in the program more than 20 years ago at a time when his severe developmental and intellectual disabilities made him angry and disruptive.

"Over the years, Noel has really become a different person and overcome so many challenges thanks to the training and education he has received from the program," his father, Nolito, says. "The communication and behavior skills they've given him have made him much calmer and able to interact with others. We also feel comfortable taking him out in the community."

The program has also made it possible for the couple to carry out family responsibilities while Noel is in the program.

"This program has really been a godsend," says his mother, Amparo. "We had no one else we could rely on, so the program has kept Noel safe and productive while letting us lead much more normal lives."

The couple could not be more grateful to the Adult Services staff.

"These wonderful staff have made all the difference in nurturing Noel to his best potential," Amparo says. "They are the most warm and caring people we have ever met, and we feel blessed for all they have done for our family."

Care Connect Helps Medi-Cal Patients Navigate Complex Health Care Environment

new Vista Hill program is helping Medi-Cal patients navligate today's complex health care environment with a host of services ranging from finding the right physicians, to making appointments and providing transportation, to connecting them with community resources like food, clothing and housing.

Care Connect, which launched in fall of 2024, hopes to

serve approximately 250 children, youth and families each year, according to Program Manager Kevin Richardson. The program is free to all those enrolled.

Using a strategy known as "Enhanced Care Management," each client is provided with a personalized health care plan customized to their specific health care needs. Among the other linked services are therapy, substance use disorder counseling, legal aid, rent and utility assistance and back-to-school supplies and other educational assistance.

Richardson says Care Connect is critical to the community because it focuses on people who tend to be most in need those experiencing homelessness, serious mental health or substance use disorders and people with intellectual or developmental disabilities. "Care Connect helps our clients focus on what they feel

their greatest needs are and advocate for them in ways that

were previously unavailable. Having someone to help walk you through resources, assist you in receiving what you qualify for and help stabilize your life during a perpetual state of crisis can make all the difference in the world."

Richardson adds, "Care Connect offers an opportunity for people who are struggling with their circumstances to avoid falling through the cracks, as they too often traditionally do. The entire community thrives when the people most in need can succeed and attain their health goals."

Cecil H. Steppe, who became a Vista Hill Board member in 2000 and served as Board Chairman since 2007, retired in November. Although Mr. Steppe has retired from active board service, he will remain an Emeritus Director.

Dr. Sidhu, who oversees Vista Hill's Native American SmartCare Program and the Substance Use Programs at Vista Hill, is also a Professor of Psychiatry at the UC San Diego School of Medicine, where he serves as Director of Training for the UCSD Child and Adolescent Psychiatry Fellowship

Program. Dr. Sidhu serves the Kumeyaay Nation as well by working on reservation as a staff child and adolescent psychiatrist at the Southern Indian Health Council in Alpine.

Dr. Patel Rao, who oversees Vista Hill's Center for Child and Youth Psychiatry and the SmartCare Behavioral Con-

sultation & Rural Programs, is a board-certified child and adolescent psychiatrist with an expertise in primary care collaborative care and early childhood mental health. She is also a Clinical Professor at UC San Diego and is current president of the regional San Diego Academy of Child and Adolescent Psychiatry chapter, and lead chair for the San Diego County Critical Issues in Child and Adolescent Mental Health conference.

"Vista Hill is extremely fortunate that Dr. Sidhu and Dr. Patel Rao believe in Vista Hill's mission so much that they want to share their world-class skills and deep

experience to improve the lives of our clients," Dean says. "Their expertise and compassion have already had a major positive impact on the behavioral health of Vista Hill clients, and we're excited about how much more they will be able to accomplish in the years to come."
